## Key factors contributing to race-based discrimination

<ul style="list-style-type: none"> <li>• Belief in racial hierarchy and racial separatism</li> <li>• Belief that some groups do not fit into Australian society</li> <li>• Fear, anxiety, discomfort, avoidance or intolerance of diversity</li> <li>• Denial that discrimination occurs and/or that it is serious</li> <li>• Negative stereotypes and prejudices</li> <li>• Failure to recognise own negative attitudes/behaviours and/or a belief that they are 'normal'</li> <li>• Poor conflict resolution skills</li> <li>• Limited positive inter-group relationships and interaction</li> </ul>	<ul style="list-style-type: none"> <li>• Organisational cultures that do not recognise discrimination or value diversity</li> <li>• Organisations that support or have weak sanctions against discrimination</li> <li>• Policies, practices and procedures that favour the majority group</li> <li>• Inequitable recruitment, evaluation, training, remuneration, turnover or promotion of staff</li> <li>• Limited opportunities for positive inter-group relationships and interactions</li> <li>• Leadership that supports, fails to recognise or has weak sanctions against discrimination or does not value diversity</li> </ul>	<ul style="list-style-type: none"> <li>• Limited relationships and interaction between people from different groups</li> <li>• Neighbourhood, family and peer cultures that are supportive of, or have weak sanctions against, discrimination</li> <li>• Resource competition</li> <li>• Local demography, historical context and community identity</li> <li>• Leadership that supports, fails to recognise or has weak sanctions against discrimination or does not value diversity</li> </ul>	<ul style="list-style-type: none"> <li>• Institutional, media, cultural and political support for, or weak sanctions against, discrimination</li> <li>• Limited connections between people from different groups</li> <li>• Impacts of colonisation</li> <li>• Inequitable distribution of material, informational and symbolic resources</li> <li>• A national identity that excludes certain groups</li> <li>• Leadership that supports, fails to recognise or has weak sanctions against discrimination or does not value diversity</li> </ul>

<p>Individuals who:</p> <ul style="list-style-type: none"> <li>• Recognise the prevalence and impact of discrimination</li> <li>• Have accurate knowledge about and are comfortable with people from varied backgrounds</li> <li>• Believe that people from varied backgrounds are equal as human beings</li> <li>• Recognise the benefits of cultural diversity, support multiculturalism and feel pride in a diverse community</li> <li>• Interact with people from varied backgrounds in respectful and just ways</li> <li>• Respond constructively to conflict</li> </ul>	<p>Organisations that:</p> <ul style="list-style-type: none"> <li>• Have policies, practices and procedures to reduce discrimination and ensure fair and equitable outcomes for clients and staff from varied backgrounds</li> <li>• Have strong mechanisms for responding to discrimination when it occurs</li> <li>• Are accessible, safe and supportive for clients and staff from varied backgrounds</li> <li>• Have strong internal leadership in the reduction of discrimination and support of diversity and model this to other organisations and the wider community</li> <li>• Model, promote and facilitate equitable and respectful inter-group relationships and interactions</li> <li>• Respect and value diversity as a resource</li> </ul>	<p>Environments that:</p> <ul style="list-style-type: none"> <li>• Encourage and facilitate positive relationships between people from varied backgrounds</li> <li>• Recognise the potential for discrimination and inter-group conflict and have strong mechanisms for reducing and responding to it</li> <li>• Respect and value diversity as a resource and demonstrate pride in a diverse community identity</li> <li>• Are welcoming, safe and supportive for people from varied backgrounds</li> <li>• Have strong leadership in the reduction of discrimination and support of diversity</li> </ul>	<p>A society that:</p> <ul style="list-style-type: none"> <li>• Has strong legislative and regulatory frameworks and appropriate resource allocation to reduce discrimination and support diversity</li> <li>• Demonstrates pride in a diverse population and promotes diversity as a national asset</li> <li>• Recognises and takes action to address the legacy of historical discrimination</li> <li>• Has policies, programs and resource allocation to facilitate positive contact between groups from varied backgrounds</li> <li>• Has strong and proactive leadership in the reduction of discrimination and support of diversity</li> </ul>
