- The standardisation of project activities as normal organisational practice
- The incorporation of project goals and outcomes into the community

1. In relation to the project itself

- Efficiency was the project efficiently implemented?
- Effectiveness was the project effective in reaching Program goals and objectives?
- Resources were funds allocated to continue the project?

2. In relation to the host councils

- 1. Culture values, mission, vision
- 2. Capacity skills, knowledge, resources
- 3. Leadership championship of food security goals at senior levels
- 4. Policy that supports food security goals
- 5. Practice that integrates food security goals into normal operations

 - Effective in terms of overall goals and objectives? Partial Some broad achievements in relation to specific
 - Continuing resource provision? Not as yet, though one Council has matched VicHealth funds to mid 2010

Conclusions

- 1. A broad lens required
- 2. It takes time to achieve sustainability
- 3. Significant resources are needed
- 4. Multi-pronged approach vital to achieve broadly defined sustainability
 - Project, host organisation and host community
 - External environment ie state or national level
- 5. Explicit focus on sustainability needed when planning pilot projects
